- I. Call to Order and Roll call at 6:19 PM
 - A. Present-Gabrielle Jackson, Jackie Velez, Tara Cross, Nicole Coakley, Shanique Spalding
 - B. Not Present-Lizzy Ortiz
 - C. Resigned- Kim Lee and possibly Alina Carcea
- II. Approval of October 2022 meeting minutes- Jackie motioned to accept, Gabrielle seconded and all were in favor.
- III. No members of the public were present to start the meeting. At 7:30 one member signed on Kathleen Hillman, she hopped on saying she was interested in learning about our Women's History Meeting. She lives in Westfield and is interested in putting on something in a park. Park is near the bridges right along the river between that and the railroad station.
