
Board of Health

**Meeting Minutes** 

June 26, 2023



The Board of Health to hold a Public Haring to discuss the temporary housing at 11 Duke Street.

Members Present: Kelly Lamas, Chair; Adrienne DeSantis, Secretary; Antonio Tavares, Member

Also Present: Paulina Matusik

Ms. Lamas: Good afternoon. Today is Monday, June 26, 2023. It is 4:30 PM. Los its order the Board of Health meeting. First order of business is the Pledge of Allegiance. The only item on our agenda today is for a public hearing at 11 Duke Street. I will first need a motion from one of the Board of Health members to open the hearing.

Ms. DeSantis: I request that we open the meeting for the hearing on 11 Duke Street.

Ms. Lamas: Do I have a second?

Mr. Tavares: Second.

Ms. Lamas: All in favor 3-0. So, the public hearing for 11 Duke Street is now open and we will begin to hear evidence and the first person up is Leslie Ward, our town Building Commissioner. Hi Leslie.

Ms. Matusik: I just want to step in so everybody knows that this is a recorded session. Everybody is on camera. Everybody that comes up I'm just going to have you state your name and title. If you don't have a title, if you don't work for the town, just state your address.

Ms. Ward: Leslie Ward, Building Commissioner/Zoning Enforcement Officer.

Ms. Lamas: Nice to meet you, Leslie.

Ms. Ward: Nice to meet you. Ok, so I was asked to weigh in on this situation. We actually did receive a complaint, from a neighbor, in the Building Department about folks that were living in a trailer in the driveway at 11 Duke Street. We did not specially go out and inspect. I was given inspection notes and photos from the Board of Health, who inspected on several occasions. At those inspections, they did find that there was a camper that was fully open, fully being used. And their inspections supported the claims that were submitted by the complainant. So, and based on the inspections and the photos, I wrote a letter to the owners of 11 Duke Street Richard and Joanne Gow in regard to violations of our zoning bylaws. There is a zoning bylaw number 3.0.6 specifically talking about mobile homes, which is what the trailer is. And in the Town of Ludlow, the only time a temporary mobile home is to be placed on the site of a residence which has been destroyed by fire or other natural holocaust for a period of not to exceed twelve months. While the residence is being rebuilt any such mobile homes should be subject to the provisions of the state sanitary code. So as far as mobile homes and people living

on a parcel that has a primary residence, which is what the house is, it's not allowed except under these conditions. Now we are backed up in our zoning bylaws by the section on prohibited uses which is section 3.2.1 which states that any use not specifically or generically listed here in meaning the allowed uses, the allowable uses for district not specifically or generically listed herein or otherwise permitted in a district shall be deemed as prohibited. Any legal use of land or building is permitted in accordance with the requirements of this bylaw except those uses which are dangerous or detrimental to a neighborhood because of fire hazard, offensive noise, smoke, vibration, harmful radioactivity, electrical interference, dust, odor, fumes, heat, glare, unsightliness, or other objectionable characteristics. So, in other words if it's not specifically allowed it is disallowed. So essentially, it's against our zoning bylaws to live in a mobile home or trailer on a property that is not a mobile home park. So that is what I have. So, I've sent a letter to the owners of 11 Duke Street stating all of this and waiting for a reply.

Ms. Matusik: If you don't have any questions for Leslie.

Mr. Tavares: I have a question. So, these people that are living in the camper, before they moved over there with the camper, were they living somewhere else? Did something happen to their house?

Ms. Matusik: That's going to be for them to discuss when they come up here. That's not a question for Leslie.

Ms. Ward: I have no idea. I don't know the specifics about the family. I don't know anything about them. All I know is that by the letter of our bylaws, what they're doing living in a camper in a residential zone is not allowed by our bylaws.

Ms. DeSantis: So, the letter went out certified?

Ms. Ward: It did.

Ms. DeSantis: Ok and it has and end date of June 30th?

Ms. DeSantis: For the corrective orders. Are they listed what the corrective orders are:

Ms. Ward: Well, removal of the trailer.

Ms. DeSantis: Ok.

Ms. Ward: Ceasing and desisting what they are doing is all.

Vis. DeSantis:

Ms. DeSantis: I mean I can assume that but I don't see that action plan in here as far as what you need to do by June 30<sup>th</sup>. But it must be taken within seven days.

Ms. Ward: Yes. And I've also given them an appeals process should they choose to appeal. They are more than welcome to do that if they like. And the zoning board of appeals can make a decision at that point.

Ms. DeSantis: If it's appealed, would they be able to stay on the property during the appeals process? Or is that totally separate from this?

Ms. Ward: They would. I would not make them. If they are going to appeal, i would not order them to leave. But they are, just by the letter of our zoning bytems, not in some figure with them. I know that there's resources for folks who are in the situation as the main.

**Ms. Lamas:** A couple of questions. So, you said that the legal addon would be times beginning after the 30<sup>th</sup> and the removal? So, what does that process look like?

Ms. Ward: If they don't do something by the date, June 30th, they're already subsidileduled to have an inspection to see if the trailer is still there and still living in the trailer. And a they are still living in the trailer the fines will begin to be issued.

Ms. Lamas: And who is scheduled for that inspection? Are you going out as well?

Ms. Ward: Actually, I don't know off hand. I believe I am. I may none git en into my local inspector Joe.

Ms. Lamas: Ok. And then so when out health inspector did go out to inspect the property you mentioned that they went and you were not there. So, is this typical for the building inspectors? I'm going to lump it, because I know there's other folks in the office that do not go out for these instances when there is a temporary home. So, it's the board of health department and it also abuts the building department. So, I'm just curious when do you some out?

Ms. Ward: Ok, so the reason I wrote the letter is to clarify what our zoning policies were based on another department's inspection. Tim Fontaine who is the health inspector, he is a town inspector. He is an enforcement official. And therefore, it's my prerogative to take his inspection for what it is and the reason for what I wrote the letter on based on his inspection. We're just overwhelmed with complaints in the building department and have been understaffed for a very long period of time. So, I was asked to do this and based on the Board of Health inspection and I did.

Ms. Lamas: Thank you Leslie.

Ms. Ward: You're welcome.

Ms. Matusik: I'm just going to present the case to you guys. Thank you, Lesile. Paulina Matusik, Interim Health Director for the Town of Ludlow. I printed out for you guys the peline and you can look at these now or later. I know you already did. This request was sent in on 2/25/23 from a Joanne Gow and then at the Board of Health meeting on 3/9/23 you guys discussed and requested the thirty days extension, which was then requested on 4/10/23 and granted. Tim went out on 2/17/23 and sent a correction order on 2/17/23 for maintenance of rubbish and garbage on the property from our CMR 410.602, as well as 410.430 for the pop-up camper located in the driveway. And I recited the codes for you guys. On 5/30/23, we received another complaint from Karen about 11 Duke Street about a rat infestation in the brush and around the pool, that there was a camper in the driveway since February, no bathroom facilities and that there no picking up after the dogs. A letter was sent on June 1, 2023 to remove the

camper and no rats were seen upon inspection. A reinspection was done on A Fall With 4-6 rats visualized running around Duke Street. This is documented in the substraint of the June 1, 2023 Tim Fontaine sent a removal of temporary housing letter stating inclation of Link 410.440 that no person be allowed temporary housing to be occupied without the written in amission of the Board of Health. On June 5, 2023 Joanne Gow from 11 Duke Strippt sent an on the requesting a hearing. This request was then discussed at the Board of Hearth meeting on a 111/23 where you guys approved the request for a hearing. On 6/15/23 the health department accertified letter regarding the hearing that was scheduled for 6/26/23. Here we have pictures from the inspections. A re-inspection was done today for you guys to take a look at. The complaints that we received are right there. The correction order that we sent is here as well. Email communications are here. Order to remove temporary housing letter and temporary housing approval. And that was the timeframe. I know you guys discussed that at the least meeting as well. I kind of went through it in more detail for all documentation as well for you guys to look at. You guys can also look at this at the end once you hear everybody that has to speak. And I'll be here if you want more, more questions. But just to kind of state the purpose, timeframe, what's been done, what's been said. So now if you guys don't have any specific questions for me at this moment, I'm going to call up 11 Duke Street if that's oxi

Ms. Lamas: Ok.

Ms. Matusik: So, for those at 11 Duke Street that would like to speak, I would just have you state your name and address. I'm just going to have you come up to the habit on that way, yeah, I'm sorry.

Mrs. Gow: First of all, my name is Joanne Gow. I'm the owner of 11 Duke Street I've owner in for 40 Years. And that letter that she was talking about I received today. That gives atm four days to remove the camper. I think that's a bit ridiculous, but also Richard Gow pass away 21 years ago. The rats, I've been complaining to the Board of Health for months. They tope me it's coming from the displacement of the mills. They went to the bar. You can go to the par and see all the trash there. They're coming under my fence from the bar and into my yard. We have put bleach. We have put peppermint oil. Everything they say online we have done. I have limited resources., I can't buy traps. But the Board of Health also said because I have animals, do not put the poisonous traps, to put glue boards. I can't afford that many glue boards, but they said I can grab the traps. I have tried and tried and tried to get rid of them. They also fined the owner of the bar numerous times. It doesn't seem to help. I don't want the rats. I have lived there, like I said 40 years, this is the first time I've seen rats. I've seen possum, skunks, whatever. I have never seen a rat. And I don't want them either. It disgusts me. But what am I supposed to do? As far as the camper. On the trash, we were cleaning up the basement. And I rented a dumpster. And all the trash was put into the dumpster, twice, and removed. My granddaughter, the first of January, was evicted from her home because they were selling it. Her kids came to live with me. There's four of them and when his kids come over, that makes seven. They come over every other weekend. They were living in their car. The first of February, they asked me if they could live in a camper in my driveway for like two weeks so they could get housing. I said yes. They couldn't come into my house because like I said I already had too many people there. I have me, my other granddaughter and her husband. And she'll be able to tell you more about this.

Because the kids have a home, a warm safe home, they are dragging their accounding them a home. DCF has been to my house numerous, numerous times. They are trying to get her into housing, but like I said, because the kids are in a safe home, they con't feel the need to do it. Stephanie can tell you all about that. I don't know about you, but if my family is faced with living in a car or living in my driveway, I said yes. I don't want to see them go Tyleg in a car, but what you decide I will abide by. But I think four days is a little ridiculous. I'd like her to come up and explain to you what's been happening with DCF and the housing authority and how much she's been trying everything. Are there any questions you have for me?

Mr. Tavares: So, Mrs. Gow thank you much for coming over here in from on as.

Mrs. Gow: It's very hard for me.

Mr. Tavares: We understand as a grandma and your grandkids and all that, the last thing you'd want is putting them on the street. I also agree with you, if you got the letter today, they're giving you four days. I think they should be giving you a few more days to find.

Mrs. Gow: They'll be getting the cancellation stub.

Mr. Tavares: So, are they planning to find a place to go and get the camper out of the yard?

Mrs. Gow: You'd have to ask her about that.

Mr. Tavares: Ok.

Mrs. Gow: But if you decide it has to go, it has to go.

Mr. Tavares: Thank you so much.

Ms. Lamas: Do you have any questions?

Ms. DeSantis: No, not yet.

Ms. Lamas: Thank you.

Mirs. Gow: Do you want to talk to Stephanie?

Ms. Lamas: Yes.

Mrs. Hunter: I do have a letter from my DCF worker for all of you guys. My name is Stephanie Hunter. I reside with my grandmother at 11 Duke Street. I started residing with her, well my children started residing with her, right after the first week of February. At that time, I called the housing department every week, every day. My DCF worker cailed them trying the get them to step up. At that point we weren't even getting phone calls back. When we would get a call back, we were told that there was such a housing crisis that they are overwhelmed. All three of my children that are residing with my grandmother, all suffer from severe separation anxiety from me. So, I thought it might have been best for me to stay instead of my car wherever I could park my car, at least in my grandmother's driveway. The reason that we are no longer in our place was that our landlords decided that they were going to up and sell, during COVID-19, the duplex I was residing at on 3105 Main Street in Bondsville. Due to not selling while the two apartments were occupied, they decided that they were going to ask the two tenants to leave the

So, in the end, it was the only place we had my grandmother's. Now my husband does not have family sehind him. Fix mother just passed away two years ago, which was the last of his. All of mind tive stated away. So, the only family we had was her and I'm proud that she's opened up to my kids. I'm proud that she wants to help me. But if you decide that the camper needs to be closed, then well close it. But in the end, that will separate my family. My three children will live with them as im wherever. And just living with my grandmother right now, my fifteen-year-old is so depressed that all she talks about, and just yesterday with since fights with the neighbors and everything else, that she wants to harm herself. So, we are trying our hardest just to hold it together and hold my damn family together. Excuse my French. I have a six-year-old, sorry she's 7 now. I have an eight-yearold that has also said these comments. They're stressed. They want a home. They ask us every day, when are we going to get out own home? And I can't answer that because I'm trying. You've got rents that have gone up so much that people with low income like me and my husband just don't have it. And most people that we've gone to look at apartments, just look at us and say sorry your income just doesn't meet our standards. We don't even get close to put in an application. So, in the end we thank the board that has allowed us to keep it open as long, but at this point that camper has been our only savior. Living in a car, I suffer from severe fibromyalgia and endometriosis, on top of half my abdomen is blown to shreds, there is nothing there. So, sleeping in a car just the few days I did in one of the coldest nights in February with no gas to run the heat, my grandmother saved me from the living heck my body was putting on. I have done everything I can to try putting a house over my family's head without us being separated the way we are. But we are just at this point that we are fighting a battle that the crisis of housing is too much. Even housing is having a problem placing their families. So, I can only go as fast as they are able to bring it. I have put in applications many times. My DCF worker has put in the applications. My DCF worker tried calling them. She doesn't even get a call back

for an update. So, we are only just doing everything we can. So, if you guys have any more questions?

Ms. Lamas: Stephanie, just so I kind of think of everything, you and your husband are living in the trailer?

Mrs. Sunter: Yes.

Mrs. Lamas: So, you're the only two in the trailer?

Mrs. Hunter: Yes.

Mrs. Lamas: And the kids are inside?

Mrs. Hunter: Three of my kids that reside there live inside.

Ms. Lamas: And can you tell me a little bit about the circumstances that have to be inside the home?

Mrs. Hunter: It is between my cousin, her husband, my grandmother, my three kids. There are two dogs because I have a dog that is also there. And they're animals, it's just so crowded. My oldest son just looked at me the first week and said I can't do this mom. He went and stayed at a friends. He's been there. Some of our other kids that come on the weekends, our oldest daughter of my husband, she only comes here and there because of the crowdedness. The house isn't built for so many people. It's a three-room house but the rooms are small. So, it's just to have me and my husband on top of that inside the house, it's just so much. It just ends up causing so much anxiety with so many people. Like I have severe claustrophobia. My cousin's husband does too. So, there's times where everybody will go into the house and I have to look and say nope I have to step outside. And I have to get to the opening so it's really just the fact that the house is just not big enough for all of us.

**Mr. Tavares:** So, DCF is trying to help you guys, I see that. And they're trying to see if they can get you a house because your goal is not to be there?

Mrs. Hunter: No, my goal was never to stay past the two weeks.

Mr. Tavares: The problem is that when one person has that, other people try to follow and do the same thing, you know what I mean? So, I understand trying to keep your family together. So, when you guys for example, like you and your husband, the only two that live in there, you guys need to use the bathroom, you guys go inside your grandma's. Is that what you do?

Mrs. Hunter: We shower and go inside my grandma's.

Mr. Tavares: And trash is just you put it out?

Mrs. Hunter: Trash is normally inside my camper until I take it over to the trash hutch that is on the other side of the house. Never trash around my camper. If anything, it's placed during cleaning a bag outside my camper door then brought over.

Mr. Tavares: Had DCF said anything like, is there any housing?

Mrs. Hunter: At this point I just received an email from her, one text messeer from her this morning with I don't know what else I can do. I'm doing everything i can. Sile sibut us in every program that she can. I didn't even have a case until losing my nouse. They cacided because I was homeless that I needed to have a case to help us and she's doing avarything she can. Unfortunately, she's told us that Massachusetts does not have a law to hair demilies where they basically state the kids are in a stable house. Like if my kids were on the stream and DCF was ready to take them, there'd be a lot more. But they'd take my kids into custody first.

Mr. Tavares: So, I imagine your grandma being there for forty years that the neighbors have gotter along with your grandmother, right?

Mirs. Hunter: No.

Mrs. Gow: Not since my husband died. There's been problem after problem.

Mr. Tavares: So, would you be able to share with us why is there some, why some of the neighbors, is it that the neighbors. What are you guys doing that's oothering it em?

Mrs. Hunter: Honestly, we don't know. We don't talk to them. We stay to ourselves.

Mrs. Gow: I am a quiet person. I stay to myself. I don't bother anybody. It's like one thing after another, after another. And I'm getting ready to file harassment charges because I'm seventyone years old and I can't deal with it anymore. Like the rats, they're not my raun, I went to the Board of Health. You have documentation for it, for months and months.

Mrs. Hunter: We have tried to battle them out.

Ms. Lamas: Excuse me, I don't mean to interrupt, so we're discussing 11 Duke Street and the temporary housing and questioning Stephanie at the table. I want to be mindful of the current process of the hearing. Do you have any follow up questions?

Mrs. Hunter: No.

They're nothing but white trash. I always have stuck up for them. I said they're compassionate people. They have a good heart. And this is how I'm paid back. I'm not a happy camper at the moment. As far as the trailer, just like everything else i've said before, it's taking away my privacy. It's right there light outside my window.

It's that they're making my life very uncomfortable. I don't feel comfortable in my yard, in my house because somebody is right there. I don't even feel like I can talk on that side of the house because they can hear me. I'm sorry, I'm a little wound. As far as the rats, I don't blame Joanne for the rats being around. I don't think anybody in our neighborhood brought a pregnant rat and said OK, let's infest the neighborhood. I could see the rats there and I wanted the Board of Health to see we have a rat problem. Which he did. I don't know what elsa to say. ''m sorry the house is crowded with everybody in there. That's their decision to do that, her decision to do that. And it's commendable. She's taking care of those kids. The two little ones since they were born. And here I am sticking up again and it's going to come back to bite me. Sorry.

I don't pay taxes for that. And if that's how it's going to continue, I'd like some kind of letter so I can get an abatement on my taxes.

Mr. Langford: Thank you.

Ms. Lamas: Tony, questions?

Mrs. Langford: Neighborhood disputes, aren't they wonderfull think they are all be in the house, I'm sorry. How can one department say this is not legal to so and the other one cannoverride it? I know you have compassion. You don't know the history. If you know the history, you'd be a little less inclined to say you know they can live in the under

Mr. Tavares: So, they said they got the letter today so it gives the relationship and everything out. And I see they got also DCF is trying to help them.

Ms. DeSantis: We'll discuss that as a board.

Mrs. Langford: There's a housing crisis, I understand that. But there is a name of got there.

Ms. Lamas: Is there a specific question you'd like to ask Mr. & Tire. Langfor II

Mr. Tavares: No.

Ms. Lamas: Any questions?

Ms. Lesantis: Nope.

Ms. Lamas: I have two questions. One is you mentioned some lights around the camper; you just tell me a little about that is?

Mr. Langford: They look like they're right on the ground, they go around the trailer and just blink.

Ms. Lamas: They light up at night?

Mr. Langford: Yes, just like Christmas lights. They're lit up until at least after i so to bed because I go around and check the doors to make sure we're locked in. And like I said, shey're right outside my dining room window.

Ms. Lamas: And what time do you go to bed on average?

Mr. Langford: I try to get to bed around 11:00 PM. Sometimes I wake up at 11:00 and go to bed.

Ms. Lamas: Ok.

Mrs. Langford: I have one more thing to say. During this argument we had the other day, Stephanie says to me "and I have every right to be here". I say why don't you go to a campground? Beautiful time of year. Why don't you put it in a campground. I know Joanne would keep the kids there if the camper doesn't accommodate everyone. She says the Town of Ludlow has told me that I can live in this camper as long as I want to and that is what I plan to do. Did the Town of Ludlow tell them that?

Ms. DeSantis: No.

Ms. Lamas: So, thank you Mrs. Langford, I'm going to ask a follow up question. If you have anything else you want to share with the board. When you've had disputes with the neighbors next door, regardless of who it is, have you called the police, when these disputes have escalated to the point where.

Mirs. Langford: This is the only time I've ever called the police.

Ms. Lamas: So, you did call them recently?

Mrs. Langford: I called them the other day when we were arguing. Figure 16, the model him he was going to knock him out. Right after Stephanie said some ver consignrations.

Mr. Langford: And their daughter also. The three of them verball attracks in the anothers.

Ms. DeSantis: What was the issue?

Mrs. Langford: The dog!

Mr. Langford: The dog. The dog started it.

Mrs. Langford: I wanted them to come to an agreement that where I was working in this part of the yard, they could tie it up or bring it inside. I don't care if the dog barks a I day. He is very aggressive. I guess he thinks he's protecting. The dog would do that. And he literally growls. And Katrina was outside talking to me, I think it was one day last week or the week before, and that dog literally her and her husband had a hard time controlling it to get it away from the fence. Because I was near the fence. All I wanted to do was come to some kind of, we could work something out.

Ms. Lamas: When the police arrived, was anything filed against them or vice versa?

Mr. Langford: The way I understood it was that if he threatened me two more times, then they would come and do something about it. So, do I have to wait until he threatens me two more times, or should I just move out until he passes away or something?

Mrs. Langford: And this is where Joanne gets the harassment from because they were given the same advice we were given. I can't see that I ever harassed her over the years. I stuck up for her.

Ms. Lamas: I understand your frustrations. Anything else?

Mrs. Langford: My big problem is living with a big camper outside my window. So when will we hear what the findings are?

Ms. Lamas: So next steps are that we would, since there's no one else in the audience to speak, we will close the public hearing and we will deliberate as a board as to how to proceed. Which will still be an open meeting.

Mrs. Langford: So, we can stay and listen to you?

Ms. Lamas: Yes.

Mrs. Langford: Will you come to a conclusion tonight or just discuss?

Ms. Lamas: i believe we will make a decision tonight as to how to proceed as a board. So, you may stay if you wish. Thank you.

Mrs. Gow: Both dogs are certified and in their own yard and it is fenced in.

**Ms.** Lamas: Alright, thank you everyone for sharing your stories. And do we have a motion by a bord member to close the hearing?

Mir. Tavares: I make a motion to close the hearing for 11 Duke Street on 10.00 2023 @ 5:15 PM.

Ms. DeSantis: I second it.

Ms. Lamas: All in favor. 3-0. The public hearing has since closed and there are no more public comments and now the board will deliberate.

Public Hearing has closed.

Wis. Lamas: Is there anything else you would like to tell us about

Ms. Niatusik: No. I mean I presented everything at the last meeting. Nothing in really changed, so nothing changed today.

Ms. Lemas: Any discussion?

Mr. Tavares: Is Adrienne going first?

Ms. Lamas: Whoever would like to go.

Ms. DeSantis: I can. You want me to?

Mr. Tavares: Go ahead Adrienne.

Ms. DeSantis: Alright, here we go. Alright, so this is a family at 1. Duke Street Landson a vary unfortunate crisis, numerous crises from mental health to dogs to housing to appear diving to quarters. It is a very unfortunate crisis that is going on for this household. Iso thes the its been going on for a while, but it's heightened with the arrival of this mailer, with the hope to manifest the crisis further and manage it without breaking up the family. So, I just want to say I completely recognize and am very empathetic to the hardship this family is enduring in the home at 11 Duke Street. I do respect clearly the efforts that DCF are making, that the housing authority are making, but the resources are clearly failing the family. The systems that are out there in the public are failing to have this family be together in a decent quality of life. Thirdly, I want to say that Stephanie mentioned that the DCF worker said that they're perpetuating this case and perpetuating the situation because they have a safe place. Well did they ever tell DCF that this is an illegal space? And I'm wondering if DCF is not aware that this is an illegal housing situation? If they would have allowed it to continue on or not? So safe is one thing, but further perpetuating an illegal situation is another. I know that the neighbors have brought up smells, noises, use of the bathroom out in the yard, odors, and the bottom line is that none of that would be, wee wouldn't be hearing about it if that was a legal fixture outside. Which would be housing with all the proper amenities. So, you know I'm looking at Leslie's left at and I 100% feel and confirm that this is an illegal housing situation. I don't think we have a confice to waive it anyway. It's we have the regulations for the purpose of preserving our town, our people, our quality of life. That's why we have these regulations. Someone thought ahead about writing one about mobile homes, and there's a reason we have that. It's not it is diffy do not at we have a regulation on mobile homes or not have mobile homes. There are reason to we're seeing it come to light. This is why we have these regulations. So, i form the light and a light an illegal situation and needs to be rectified immediately and that this its in this purpose is comportunately with coming up with a resolution to further their family. I would, though, take into consideration what Tony said about not also agreeing that four days, I moan Mindow that have no morrise, you got to take out your camper has been kind of all along. But the four a value of the sound and sould amend that to seven days from receipt of the notice. I would such orbitish it is something that we can do, or do they have to go through Lesile?

Ms. Lamas: So, this notice is through Leslie. So, this is a notice under her jurishington. Our jurisdiction is our temporary housing permit that has since expired now many a paths ago.

Ms. DeSantis: Months ago. I mean this is no surprise. This has been there. This se regulations have been there all along too and we've, I'm not going to say, neglected them or we haven't addressed them.

Ms. Lamas: We as a board have. Like our jurisdiction, we did what we could in the moment right when we received the complaints, we followed up on them. So, I think we've done what we could given our governing authority.

Ms. DeSantis: Since February.

Ms. Lamas: In the bylaws. Thank you,

Ms. DeSantis: So, that's my take on it. And I don't need to hear more about the smells and the odors or the lights or the dogs. The bottom line is we have an inegal situation analyneeds to be enforced.

Ms. Lamas: Yes. Tony?

Mr. Tavares: Just a couple of things. I understand from both sides. You know I understand the neighbors if they're afraid of the dog. You know the last thing you want is getting bit by the dog. Or the other thing is the guy charging someone, or I don't know what he said or trying to hut him. I also understand that's inappropriate. My only thing is, my question is, is there a town ordinance in our town bylaws?

Ms. Matusik: Regarding what?

Mr. Tavares: You know that they cannot leave that camper on there?

Ms. Lamas: Yes, it's in the zoning bylaws that we discussed.

Ms. Matusik: It's what Leslie printed out.

Ms. Lamas: The mobile homes, that's one bylaw. And the other briaw is the lated uses, which list off various. So, if it's not allowed it's not allowed it's not allowed. which list off various. So, if it's not allowed, it's not permitted. So, any legal us of land of U building, fence, noise, fire hazard, smoke, this is all that's prohibited. These are the two bylaws that prohibit specifically this mobile home, yes.

Ms. Matusik: This is our zoning bylaws. Leslie typed up the letter which it showed you guys at the last meeting.

Mr. Tavares: My other question is Leslie sending out the letter and she hash and lowed up too, going there.

Ms. Matusik: So, Leslie sent out the letter Friday and they just good today.

Mr. Tawares: They just got it today.

Ms. Matusik: Yes. But what Leslie does with this letter or her denortiment, we use it control, and neither can you guys as a board unfortunately.

Ms. Lamas: And there's the Mass General laws that are neighbor thinking a countral numbers. Right, boards of health are required to examine nuances. Ok, so I echo your sentments Adrienne in thinking that this is a really tough situation. I empathize with the family common by a few times over the weekend just to kind of assess as well. A couple of things, I think the comble I'm sure, I can probably assume, that there are a lot of things going on with mental illusing and other conditions that may preclude somebody from living in the home and vice versa. We don't have that presented as evidence. I also, for me, I'm looking at facts that's presented in front of me. It's a little concerning to not have an official letter, emailed to the poard, from the DCF worker kind of laying out the full story of what's happening.

Ms. DeSantis: I would think they would have been here.

Ms. Lamas: Or speaking or something. So that's a little, for someone who's worked with DCF, that would make me think that at least sending an official letter to the board latting them know what's happening. From a Board of Health perspective again, our first permission was granted what on February 14<sup>th</sup>? Yes, February 14<sup>th</sup>. Camper for thirty days.

Ms. Matusik: It was granted on 3/9/23.

**Ms.** Lamas: So that letter was sent in and granted and then given an additional 30 days on April the 10<sup>th</sup>, correct?

Ms. Matusik: Yes.

Ms. Lamas: So, I'm reading this correctly. Ok. So, I think that separating the latter from Leslie, I think as a Board of Health, like from my perspective, we've done our due diffgence as a board to have temporary permits, extending the temporary permits. There has been, so we saw, at our last meeting, a kind of a lapse in communication from 11 Duke Street in what was happening and staying kind of on top of their own situation in notifying the board what was happening or communicating with us. So, this is kind of the first time that we've had real legitimate, I would say, communication on who was speaking, names, etc. So, we've had multiple smalls, but it was very vague on who was sending those emails. So, that's what in the latter is to have

Ms. DeSantis: Can we do anything about the grille next door? I may they get medected for food inspections twice a year.

Mr. Tassares: They're actually closed.

Mis. Lerras: They're closed.

Mr. Tawares: They've been closed for 3 ½ years.

Mis. Lamas: Yeah, since pre-covid.

Mis. Desantis: Why are the rats coming from there?

Mr. Tavares: I think the rats are coming from the river.

And I think this is more specifically regarding the temporary housing which we granted twice since March, and we are essentially going to be July 1st by the end of the week. Yeah, for me thinking about all sides, I understand that folks may be struggling with mental lilness and anxiety and not have enclosed quarters. And there's a home there so I think that worse case scenario, that's what I imagine happening if the temporary mobile home being removed and the kies you know. I think our hands are tied based on what we need to do. My opinion, we can empathize for a lot you know, it's tough. There's no evidence of the dogs with ESA which is a sense the case in itself. Part of this public hearing is presenting the facts and we have the facts in francial at Me've heard folks share their stories and experiences. Discussion? Questions' Thoughts I have decision today would be to not grant a permit for temporary housing?

Ms. Matusik: Yes. So, the order that was sent was to remove the coupling. In Ms. printed it out for you guys. If not, this was the order that they're request. We have a more than scheduled board meeting. On March 9th, the board discussed your request in have a more set up in your driveway as temporary housing for your granddaughter. The positivotes are induced to use the campen as temporary housing for up to 30 days. There was an embrane read to long 30-day extension received on April 10, 2023. As of today, the trailer is so losing once the set reporary housing. This is a violation of 105 CMR 410.440 temporary housing for any further questions, please contact the department.
