### Golf Professional - Bill Kubinski

Bill Kubinski- I passed out copies of this year's golf pass pricing so everyone can review them, and we can discuss what we want to do with prices for next year. We have had a few people inquire about 2026 pricing and when the passes will be available.

McBride- do we want to kick this around tonight or would everyone like to look this over and come back to it on October 14<sup>th</sup>?

Lebeau- overall I think we're pretty well priced, I know we went up last year and feel good about our pricing.

McBride- I tend to agree, I think if you play like 70 rounds you're averaging like \$20/round. Morton- I like how we created more of a split between resident and non-resident last year. I would like to keep that spread or possibly go up further on the non-resident pricing.

McBride- the price seems reasonable, we're not giving it away but not to high ether.

Kubinski- I think we could go up \$100 on the 7-day passes and less on the 5-day and weekend pass accordingly.

McBride- and leave the cart pass alone?

Morton- I would go up on the golf only because everyone bets the golf but not everyone goes with the cart pass so to maximize the increase we should focus on golf.

Lebeau- agree, leave the carts alone and go up on the golf.

Morton- maybe we go up \$100 on the 7-day, \$50 on the 5-day, and \$25 on the weekend? McBride- I like that, I would entertain a motion on that.

Lebeau- I would like to make a motion that we go up \$100 on the 7-day, \$50 on the 5-day, and \$25 on the weekend golf passes and leave the junior and cart passes the same.

Morton-second

McBride- all in favor? Motion passes 4-0

Kubinski- thank you, I will get this information out to the individuals who have been inquiring.
