REPORTS:

Golf Professional – Bill Kubinski

Bill Kubinski- I have handed out our October revenue update with comparisons to the last 11 Octobers. Tomorrow we will hit \$57,000 at the halfway point of the month which would put us on pace for about \$108,000 for the month assuming a couple rain outs and that we start seeing a smaller daily average as the month goes on. As you can see, if we can get to that \$108,000 mark it will be the second highest October, we've ever had so that would be a good goal to get to.

Kade Howard- We have started selling next years memberships, the form is available in the proshop and online. So far, we have sold two memberships for next year.

Mario Morton- Has there been any feedback on the price increase?

Kade Howard- No, we haven't heard much about the increase either way.

Superintendent - Ryan Linton

Ryan Linton- The past couple weeks have been pretty good. Everything on the course is going well, we did bring in an irrigation technician to help us diagnose the electrical issues that have been ongoing out on the golf course. For the past two years we have been struggling with electrical controls on the 2nd hole, 8th green, 3rd tees, and 9th tees. The tech was able to get everything on the 2nd hole back operational. Hopefully he can get back here this fall and we can continue working on the other issues. Besides that, we're into leaf season and that will be our primary task for next month, just keeping the course clean and dealing with all the leaves.

Sean McBride – Have we heard from Tighe & Bond?

Ryan Linton – No, we have not heard directly from Tighe and Bond however we have met with TPC who is working on the preliminary design for Tighe & Bond. I do have a copy of that design with me today. This design is for everything, all new double row irrigation with HDPE piping, ins and outs on the greens and full circles everywhere else. I just need to know what you guys are thinking as far as pulling things back to bring down the price point. The first thing that I noticed is that the driving range field is fully irrigated, is that something we want to get rid of? Do we want to try and go single row on the holes that are narrow enough to get away with it to save money?

Shawn Lebeau – For me, I want to see multiple options. I know we talked about being able to use the current piping and redoing the wires and heads or doing the whole thing.

Sean McBride – I agree, I don't want to look at one option. We need to see multiple options at varying price points so we can make an informed decision.

Ryan Linton – To answer the previous question there are a few options, the most expensive being a whole new system which in my opinion is what's desperately needed. Option two would be to run new control wires throughout the course and convert all the existing heads to a two-wire system. This would eliminate all our ongoing electrical and control issues but would obviously do nothing to address the ongoing irrigation pipe and heads issues. And option three would be to simply replace the current pumps and keep going with the existing pipes, heads, and electrical system.

Sean McBride – It comes down to what we think we can sell at Town Meeting. With that being said, I think it's fair to say that the Cadillac is out of question. We need 2-3 options to look at and see what we want to go with.

Sean McBride – What kind of construction timeline are we looking at for a project like this.

Ryan Linton- We did go over this when Gary was out for the meeting with TPC. A typical full installation will be for about 4 months. They do work with you to keep the golf course open at all

times. However there will be a hole closed at all times during construction. They do their best to keep everything contained to one hole at a time. Some courses will turn 18 into two par 3s to make up for a hole being closed, others will just allow you to go play 1 or 10 again to make up for it.

Ryan Linton- So for our next step do you want me to have TPC or Tighe & Bond come out for a meeting to answer some of the questions that you have at this time?

Sean McBride – Yes, but we want more information before having them come out. We need conceptual's and reports from Tighe & Bond prior to meeting so we can be prepared and have all the questions ready before the come out.

Mario Morton – I agree, we need to understand the consequences of our decisions.

Sean McBride – The long-range planning and budget and finance subcommittees really need to get together on this and dive into the reports and conceptual designs and really understand what's at stake prior to Town Meeting. To be able to sell this we will need to be knowledgeable and be able to answer every question thrown at us. Ultimately, we need a functional and reliable system somewhere in the middle. We cannot go for the Cadillac, and we cannot go for another band aide that will bring us back to Town Meeting in 10 years with more issues.

Ryan Linton – okay, I will reach out to Tighe & Bond and hopefully have more information for the next meeting.
