Pre-election Report (8th day before election) due March 18, 2024:

Reporting dates: January 1, 2024 through March 8, 2024 (Reporting dates 18 days before election)

30-Day Report due April 24, 2024:

Reporting dates: March 9, 2024 through April 14, 2024 (Reporting dates 20 days after election)

Year-end Report due January 21, 2025:

Reporting dates: April 15, 2024 through December 31, 2024 (Reporting dates through end of the year)

Must have the original signatures of the Treasurer (if the Candidate has a committee) and the Candidates signature. Any Candidate with that carry over balances or liabilities, have additional financial activity or are incumbents are to file campaign disclosure report (Form CPF M102). The obligation to file both before and after the election applies to all candidates, win or lose.

If a Candidate does not have a political committee organized on their behalf and has not received any contributions (<u>including from their own personal funds</u>), made any expenditures or incurred any liabilities and they do not have a previous campaign balance, they may, if they choose, simply sign an M102-0 affidavit form stating those facts. Even those who do not raise or spend any money must sign a form saying they have had no activity.
