### **COMMONWEALTH OF MASSACHUSETTS**

To Ms. Kim Batista, Town Clerk of the Town of Ludlow, Massachusetts in said County:

#### **GREETINGS:**

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of the Town of Ludlow, who are qualified to vote on Town affairs, to meet at the **LUDLOW HIGH SCHOOL**, 500 Chapin Street, Ludlow, Massachusetts on **MONDAY, January 9, 2023 at 7:00 p.m.** for the purpose of acting on the following articles in the warrant.

**ARTICLE 1:** To see if the Town will vote to place a question on the March 2023 Annual Town Election ballot for the purposes of the Board of Selectmen to act as the Board of Public Works. The question to read as follows:

**“Shall the town vote to have its selectmen act as the board of public works?”**

Pass any vote or take any action relative thereto. Submitted by the Board of Selectmen.

**ARTICLE 2:** To see if the Town will vote to place a question on the March 2023 Annual Town Election ballot for the purposes of combining the elected Treasurer and elected Collector into one appointed Treasurer/Collector position. The question to read as follows:

**“Shall the town vote to have its elected Treasurer and elected Collector become an appointed Treasurer/Collector of the town?”**

Pass any vote or take any action relative thereto. Submitted by the Board of Selectmen.

**ARTICLE 3:** Pursuant to G.L. c.164, §134, to see if the Town will vote to grant Board of Selectmen the authority to research, develop and participate in a contract, or contracts, to aggregate the electricity load of the residents and businesses in the Town and for other

related services, independently, or in joint action with other municipalities, retaining the right of individual residents and businesses to opt-out of the aggregation.

Pass any vote or take any action relative thereto. Submitted by the Board of Selectmen.

**ARTICLE 4:** To see if the Town will vote to accept the provisions of MGL chapter 143, section 3Z, in order to permit a part-time Building Inspector to practice for hire or engage in the business for which (s)he is certified, licensed or registered under the State Building Code, while serving as such inspector.

Pass any vote or take any action relative thereto. Submitted by the Board of Selectmen.

And you are directed to serve this warrant by posting attested copies of the same in seven (7) public places in the Town fourteen (14) days before the time of holding said meeting.
